## ORDINANCE NO. 2012-002

AN ORDINANCE AMENDING ORDINANCE NOS. 90 AND 2003-4 TO PROVIDE FOR AN EXCLUSIVE CONTRACT TO DEDMAN'S SANITATION FOR SOLID WASTE DISPOSAL SERVICE FOR TYRONZA, ARKANSAS, ESTABLISHING FEES, A PENALTY, AND FOR OTHER PURPOSES.

WHEREAS, the City is desirous of entering into a contract with Dedman's Sanitation for the provision of solid waste disposal services within the City upon the terms and conditions of the proposed contract and rate structure exhibited to the City Council.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Tyronza, Arkansas, as follows:

- SECTION 1. That Ordinances No. 90 and 2003-4 shall be amended to provide for Dedman's Sanitation to provide solid waste disposal services to the City upon the terms set forth in the proposed contract and rate structure exhibited to the council, and the mayor and recorder/treasurer are authorized to execute such on behalf of the City, such providing for, among other things, a one year term subject to automatic renewal unless either party gives written notice of termination not less than 90 days prior to the anniversary date of the contract, with such service to be provided at the following rates:
- A. Residential pickup: \$13 per month for one pickup per week for 1 cart and \$18 per month for 2 carts;
- B. Small commercial accounts: \$17 per month with one pickup per week for 1 cart and \$22 per month for 2 carts; and
- C. Large commercial accounts: 2 yard dumpster one pickup per week \$55 per month; 3 yard dumpster one pickup per week \$65 per month; 4 yard dumpster one pickup per week \$75 per month; 6 yard dumpster one pickup per week \$95 per month; 8 yard dumpster one pickup per week \$115 per month.
- $\underline{\text{SECTION 2}}$ . The City shall retain five percent (5%) of all amounts collected as a fee for collecting garbage and sanitation fees on monthly water bills provided to users.
- SECTION 3. All residential and small business garbage shall be bagged prior to placement in carts.
- SECTION 4. Carts shall be removed from the curbside by the residential or small business user by the end of the day.
- SECTION 5. This ordinance shall supersede only those ordinances and parts of ordinances expressly in conflict herewith.
- SECTION 6. That a violation of this ordinance shall be punishable by a fine of not less than \$10 and no more than \$50, and each day such violation continues shall constitute an additional offense.

SECTION 7. That the City's contract with its existing solid waste disposal contractor ends this month, and it is necessary to enter into a new contract to provide for solid waste disposal for the City, so this ordinance being necessary for the preservation of the public peace, health and safety, shall be in full force and effect from and after its passage.
